The Vendor has the absolute right to change the closing date and/or time of the tender from time to time by amending the Sales Arrangements.

Persons interested in submitting tenders of the specified residential properties are reminded to read the latest register of transactions of the Development so as to ascertain whether a particular specified residential property is still available for tender. A specified residential property will become unavailable for tender once the Vendor accepts a tender at or before 11:59 p.m. on the same day after the close of a previous tender exercise of that specified residential property (whether under this Sales Arrangements or any other Sales Arrangements). Please note also that the register of transactions of the Development may not be updated immediately after the Vendor accepts a tender.
