Details of the arrangements will be announced on the website of the Development or by such other means as the Vendor considers appropriate and interested persons will not be separately notified of the same. The Vendor reserves the absolute right to reject any person to enter into the Sales Office and/or any designated venue. The Vendor's decision in this regard shall be final and binding on all persons.
